

# Early Bird Giveaway Terms & Conditions

## CONTEST PERIOD

The Contest begins on March 8, 2024 and ends on June 30<sup>th</sup>, 2024. The contest is solely organized and sponsored by Access Credit Union.

## ELIGIBILITY

The Contest is open to all individuals who have registered for the Access Charity Golf tournament between March 8 and June 30<sup>th</sup>, 2024, who are of the age of majority at the time of entry into the Contest. Employees and representatives of Access Credit Union or its subsidiaries and affiliates, are not eligible to win, nor is any person of their immediate families. For the purposes of this contest, immediate family is defined as parents, spouse, children, and siblings. Additionally, anyone, whether related or not, living in the same home as the employee or representative are not eligible to enter.

## HOW TO ENTER

To enter, entrants must register for the Access Charity Golf Tournament between March 8 2024, and June 30, 2024. Registration includes: Golfer or Sponsor registration (only sponsor packages that include golfers are eligible).
